FORWARD

The equipment included in this listing has been rated acceptable for use in dairy plants surveyed and approved for USDA grading service.

The Dairy Grading Branch conducts design reviews and prototype inspections according to the regulations set forth in the General Specifications for Approved Dairy Plants and Standards for Grades of Dairy Products as outlined in 7 CFR 58.101 through 58.938, and the principles, guidelines, and criteria established by the 3-A Sanitary Standards Committees, and the USDA Guidelines For The Sanitary Design and Fabrication of Dairy Processing Equipment.

The general requirements for construction, repair and installation as outlined in section 58.128(a) reads as follows:

Section 58.128 Equipment and utensils.

(a) General construction, repair and installation. - The equipment and utensils used for the processing of milk and manufacture of dairy products shall be constructed to be readily demountable where necessary for cleaning and sanitizing. The product contact surfaces of all utensils and equipment such as holding tanks, pasteurizers, coolers, vats, agitators, pumps, sanitary piping and fittings or any specialized equipment shall be constructed of stainless steel, or other materials which under conditions of intended use are as equally corrosion resistant. Nonmetallic parts other than glass having product contact surfaces shall comply with 3-A Sanitary Standards for Plastic or Rubber or Rubber-Like Materials. Equipment and utensils used for cleaning shall be in an acceptable condition, such as not rusty, pitted or corroded. All equipment and piping shall be designed and installed so as to be easily accessible for cleaning, and shall be kept in good repair, free from cracks and corroded surfaces. New or rearranged equipment, shall be set away from any wall or spaced in such a manner as to facilitate proper cleaning and to maintain good housekeeping. All parts or interior surfaces of equipment, pipes (except certain piping cleaned-in-place) or fittings, including valves and connections shall be accessible for inspection. Milk and dairy product pumps shall be of a sanitary type and easily dismantled for cleaning or shall be of specially approved construction to allow effective cleaning in place.

All CIP systems shall comply with the 3-A Accepted Practices for Permanently Installed Sanitary Product, Pipelines and Cleaning Systems.

It is Dairy Grading Branch policy to fully support the established 3-A Sanitary Standards Programs and to encourage equipment manufacturers, distributors, and the dairy plant and users to participate fully in the development and application of the 3-A Sanitary Standards and Accepted Practices. All equipment which fully complies with the criteria set forth in the applicable 3-A Sanitary Standards or 3-A Accepted Practice is accepted as meeting the requirements of the USDA General Specifications. This equipment listing is not intended to include all equipment which complies with established 3-A Sanitary Standards or Accepted Practices. There may be instances, however, when such equipment is included in this listing in order to provide clarification about its use within dairy plants surveyed and approved for USDA grading service.

Equipment which is not covered by established 3-A Sanitary Standards or Accepted Practices will be reviewed by the Dairy Grading Branch utilizing requirements of Section 58.128 of the *USDA General Specifications and the USDA Guidelines For The Sanitary Design and Fabrication of Dairy Processing Equipment*.

As appropriate, regulations for the Food and Drug Administration (FDA), Department of Health and Human Services will be used to determine the suitability of component materials and processes with respect to public health concerns.

Equipment reviews and acceptances by USDA Dairy Grading Branch are separate and apart from any other USDA review process. Equipment designs submitted to and accepted by other USDA agencies are not transferable to Dairy Grading Branch.

These reviews are not intended as a USDA endorsement of the equipment's ability to function according to advertised statements or manufacturers claims of performance. The reviews are for sanitary design, fabrication and cleanability features only.

When a manufacturer's advertising references USDA acceptance, the correct terminology is "Model has been reviewed and accepted by the Dairy Grading Branch, USDA for use in dairy plants surveyed and approved for USDA grading service."

EQUIPMENT REVIEW PROCEDURE

Equipment may be submitted for USDA, Dairy Grading Branch review by the designer, fabricator, distributor, or end user. The equipment may be reviewed from blueprints, prototypes, pilots, or full size units. In most cases, cost savings can be realized by beginning the review process during the blueprint design stage of development.

The Dairy Grading Branch is a user fee supported service. Therefore, charges will be made for the review of drawings or equipment and for related travel and other expenses.

Engineering drawings of the entire piece of equipment are generally required for evaluation of details for USDA acceptance. Engineering drawings must be of sufficient detail to clearly show:

- The dimensions of each part;
- The minimum radii dimensions of internal angles of less than 135 degrees;
- The product contact surface finish specifications;
- The specifications for welds and other permanent joints;
- The design details for flanges, or gasketed joints which are to include enlarged drawing(s) (at least 2X) of the details of O-ring retaining grooves as appropriate;
- The dimensions of O-rings, gaskets, and any other type of seals; and
- Explanations about company welding symbols and metal finishes.

Dimensions may be shown in either English or metric measurement terms. The required materials listings and terminology on the drawings should be in English or include translations into English. Concept or assembly drawings should also be provided as they are useful in showing the general configuration of the equipment and the relationship of component parts to each other.

The review will encompass three aspects; design, construction materials and fabrication as they relate to the equipment's cleanability. Design review will include both product contact and nonproduct contact surfaces in accordance with the criteria outlined in the Foreword section of this publication. Fabrication will be evaluated by the physical inspection of completed units, usually at the fabricators facilities or at the dairy plant. The equipment will be checked for workmanship, metal finish, and adherence to the accepted drawings. Cleanability will be evaluated on a completed unit after a period of actual use. The cleanability inspection may require extensive disassembly of component parts to fully evaluate design characteristics as they relate to cleanability.

Equipment cleanability is directly related to the basic design. In general, equipment for manual cleaning must be designed so that access to product contact surfaces can be easily achieved with the use of simple tools generally available to a dairy plant production employee. Equipment intended for CIP (cleaning-in-place) cleaning must be designed so that all product contact surfaces will be subjected to sufficient cleaning solution to completely remove all product residue during the cleaning cycle. While bacterial swab tests of cleaned surfaces and bacterial tests of finished products are important indicators of cleanliness, they will not constitute the sole criteria of design suitability. Physical inspection of surfaces will be the primary method for the evaluation of cleanability.

Equipment offered for review should be designated by a specific model number or descriptive name for clear identification. Equipment which may be manufactured in both sanitary and non-sanitary configurations may bear the same basic model number provided that a prefix or suffix is added to clearly differentiate the styles.

Equipment submitted for design review during the blueprint stage will be granted a preliminary acceptance pending satisfactory demonstration of fabrication workmanship and cleanability. Full, unrestricted acceptance will be granted upon successful completion of all three aspects of the review process.

Acceptance will be further identified according to the mode of cleaning for which the unit is designed. The acceptance will be designated as follows:

Manual - Acceptance when cleaning is accomplished by complete disassembly and manual cleaning.

Partial CIP - Acceptance with CIP cleaning of major portions of the unit and with the disassembly and manual cleaning of some component parts.

Full CIP - Acceptance with complete CIP cleaning of entire unit.

Upon acceptance of a particular unit, the manufacturer accepts the responsibility of informing the USDA, Dairy Grading Branch, about subsequent design changes and to submit such design modifications or improvements for review and acceptance.
