1. PURPOSE

This notice announces changes to certification procedures for Chickpeas/Garbanzo Beans and amends the data collection requirements of the United States Department of Agriculture (USDA), Agricultural Marketing Service (AMS), Federal Grain Inspection Service (FGIS), Inspection Data Warehouse (IDW).

2. BACKGROUND

FGIS will be updating multiple factors in the Agricultural Product Standards (APS) for the certification of Chickpeas/Garbanzo Beans. These factor updates include generating needed factors, removing unnecessary factors, and removing multiple names used to represent the same factor result. These changes are necessary for providing uniform results and generating reports when searching information for a single factor (i.e., Damaged Beans) instead of performing multiple searches for a single factor with multiple names (i.e., Total Damage, Damaged Kernels Total, Damage). These changes will help customers better understand inspection criteria and results.

3. EFFECTIVE DATE

This program notice is effective April 13, 2025. Any third-party software used must be updated by the effective date.
